COD Terms Preferred

Furthermore, it is understood that the supplied information is confidential and shall be regarded as continuous until cancelled via writing, **via Certified Mail**, to Gravitas Wine Marketing credit department. Further, purchaser shall notify Gravitas Wine Marketing, **via Certified Mail**, of any change of ownership, at least 10 days prior to the effective date of said change. The undersigned agrees that the foregoing information is true and accurate and agrees to neither order nor accept goods from Gravitas Wine Marketing while insolvent within the meaning of Uniform Commercial Code Section ("UCC") 1201 (23). Every order placed, or delivery accepted, while customer is insolvent shall constitute a written misrepresentation of solvency to the seller within the meaning of UCC Section 2702 (2). And to pay, when due, all invoices from Gravitas Wine Marketing, and any invoice past due is subject to a 1-1/2 percent per month (1.5%) Finance Charge. Further, I/we hereby authorize any of the bank, trade references or agents of Gravitas Wine Marketing to provide any and all information requested and also authorize them to obtain credit reports on the applicant(s), principal(s), or its guarantor's from sources of its choice whenever it chooses, at its sole discretion.
